Notice is hereby given that sealed bids will be received by the Borough of Ringwood, for the REHABILITATION OF THE SKYLINE 792 0.9 MG WATER STORAGE TANK, Contract Numbers 2015-102 C and 2015-102 S, and will be opened and read in public at Ringwood Borough Hall, 60 Margaret King Avenue, Ringwood, New Jersey, on the fifth day of April, 2016 at 10:00 AM prevailing time.

**CONTRACT C – TANK AND COATINGS REHABILITATION**  
**CONTRACT S – TEMPORARY WATER SERVICE**

The work includes the furnishing of all labor, material and equipment necessary or required to complete all work set forth in these Specifications and shown on the Plans.

Attention is directed to the IB sheets for critical dates and events within the bidding period including the pre-bid conference and site visit on the twenty-fourth day of March, 2016 at 10:00 AM, final date for consideration of substitutions, and final date for bid document inquiries.

Plans, Specification and forms of bid for the proposed work prepared by H2M Associates, Inc., consulting engineers and approved by the Borough of Ringwood have been filed in the office of said BOROUGH CLERK, at 60 Margaret King Avenue, Ringwood, New Jersey, and may be inspected by prospective bids during the regular business hours. Bidders will be furnished with a copy of the Specifications, Plans and Proposal by the BOROUGH CLERK at the cost of preparation thereof, \$100.00, nonrefundable; plus \$15.00 postage and handling if mailed.

Bids must be made on the standard Proposal form in the manner designated therein and must be enclosed in a sealed envelope bearing the name and address of the bidder and the name of the project on the outside, addressed to the Borough of Ringwood, and must be accompanied by a Certified Check, Bid Bond or Cashier's Check drawn to the order of the Borough of Ringwood for ten percent (10%) of the total amount bid, provided said security need not be more than \$20,000.000. All bid guarantees shall be accompanied by an executed consent from an approved surety company,

licensed to conduct business in the State of New Jersey, agreeing to furnish the required Performance and Maintenance Bond upon the award of the contract.

The signed Proposal forms and bid security must be delivered to the place and on or before the hour named above. The accepted bidder must sign the contract within ten (10) days after the Notice of Award or forfeit his bid security. Bid securities will be returned to all but the three apparent lowest responsible bidders. All other bid securities will be returned within three days after awarding and signing of the contract and approval of the Contractor's Performance Bond, Saturdays, Sundays, and Holidays excepted.

All bidders are required to comply with the requirements of N.J.S.A.10:5-31 et seq. and N.J.A.C. 17:27, as amended and supplemented from time to time. In addition, bidders are notified that they must pay the prevailing wage rate as determined by the "New Jersey Wage Act, Chapter 150, of the Laws of 1963", extension effective July 1974.

The right is reserved to reject any or all Proposals, in whole or in part, or to make awards to such bidder or bidders who, in the judgement of the Borough of Ringwood makes the most advantageous bid and to waive such informalities as may be permitted by law.
