SERVICES OFFERED

The health department offers the services of a licensed health officer (HO), registered environmental health specialist (REHS), public health nurse supervisor and public health nurses (PHN), certified health education specialist (CHES), board-certified pediatrician (MD), certified municipal registrar (CMR), and animal control officer (ACO). To keep costs down, Ringwood utilizes shared services agreements for some of the services provided.

BOARD OF HEALTH



The BOH reviews public health trends, discusses issues and events that happen on a local, state-wide and national level, while assessing best practices to guide the health department in meeting the 10 essential public health services.






SARS-CoV-2 Pandemic



Coronaviruses are a family of viruses that typically cause mild respiratory infections like the common cold, but also more severe (and potentially deadly) infections. They are zoonotic diseases, meaning they are transmitted from animals to people. Coronaviruses are named after the Latin word corona, meaning "crown" or "halo," because they have "crown-like spikes on their surface," according to the U.S. Centers for Disease Control and Prevention. The novel coronavirus responsible for this outbreak is known as SARS-CoV-2. The illness caused by the virus is called COVID-19. Common signs of coronavirus infection include runny nose, cough, fever, sore throat, and shortness of breath.COVID-19 can cause a wide range of signs and symptoms at varying levels of severity. The most common are fever, dry cough, and tiredness. Other symptoms include shortness of breath or difficulty breathing, muscle aches, chills, sore throat, headache or chest pain. Other symptoms that aren't as common include: gastrointestinal symptoms, new loss of smell or taste, skin changes (like lesions), confusion, and eye problems. The first case of COVID-19 in the United States was a 35 year old male in Seattle on January 20th. March 3rd marked the first New Jersey case. It wasn't long before Ringwood had its first case on March 17th. Since that time, Ringwood has had 561 cases and lost 7 residents to COVID-19 in 2020. Case investigation and contact tracing was coordinated by the Public Health Nurse Supervisor. Testing was performed in Ringwood and throughout the county to help stop the spread. Like many communities we mourn the loss of our neighbors and friends, and recognize the valiant effort of those on the front lines...in hospitals, long term care facilities, doctors' offices, food stores and schools, and as a community, supporting one another in any way we could.

GRANTS

The Borough of Ringwood has been the recipient of several grants during 2019/2020:

- New Jersey Highlands Council Environmental and Economic Sustainability Grant provided \$91,555 for a Watershed-Based Assessment of the lakes. This 2020 analysis was performed by Princeton Hydro, LLC, and included identifying factors contributing to eutrophication and water quality impairments, and recommendations for watershed management measures.
- 2) Chilton Medical Center/Atlantic Health System awarded \$20,000 through the New Jersey Healthy Communities Network. This grant will be used over 2 years, and has partially funded the installation of exercise equipment at the Eleanor G. Hewitt (EGH) School that will be used by the community. A walking path is planned for 2021. Aeroponic Growing Towers and "The Walking Classroom" will be purchased and used by students at EGH to increase knowledge about healthy eating and active living.
- 3) The New Jersey Department of Health awarded approximately \$23,000 towards the COVID-19 pandemic response, which has included a tabletop preparedness exercise held on March 16th and case investigation/contact tracing efforts.
- 4) Chilton Medical Center provided a \$7,000 grant in 2019 for Stigma-Free initiatives, which has been carried through into 2020 with our Mental Health Mondays, More than Muscle and Youth Exercise programs during the summer.



HEALTH EDUCATION AND PROMOTION

Health Education is provided under the guidance of the Public Health Nurse Supervisor. Programs and screenings are provided by the Ringwood Health Department, Chilton's Community Health Department and in collaboration with partners such as ShopRite, Ringwood Public Library and William Paterson University and Montclair State University interns. Starting in March our focus and efforts were directed towards a pandemic response.

STIGMA-FREE

The Borough of Ringwood was awarded a grant in 2019 from Chilton Medical Center to raise awareness and advertise valuable resources about Stigma-Free. The Stigma-Free initiative aims to reduce the stigma associated with mental health conditions and substance use disorders. Individuals who are struggling with these disorders often do not seek treatment because of the shame they feel from themselves and others. By educating our community, people will seek the treatment they deserve. We hope to mobilize family, friends and neighbors to offer compassion and support. Because of the pandemic, we could not provide many of the programs and trainings that we would like, but transitioned to a virtual ***Mental Health Mondays** (relevant health topics at the Ringwood Library), **More than Muscle**, and **Youth Exercise Programs**. With stress, anxiety and depression caused by the pandemic, these programs improved mood, decreased anxiety, lowered stress levels and boosted selfesteem.



PUBLIC HEALTH NURSING

Public Health Nursing is the practice of promoting and protecting the health of populations using knowledge from nursing, social and public health sciences. The Public Health Nurse Supervisor coordinates and provides services for all age groups in Ringwood. These services include health screenings, well-child check-ups, pediatric and adult immunizations, school immunization audits, communicable disease investigations, home visits to vulnerable individuals and emergency preparedness. A board-certified Pediatrician provides services for the Child Health Clinic, and per diem public health nurses and other health professionals aid the Public Health Supervisor in many screenings and clinics.

ENVIRONMENTAL HEALTH SERVICES

Environmental health is the branch of public health concerned with monitoring or mitigating those factors in the environment that affect human health and disease. All aspects of the natural and built environment are monitored by a Registered Environmental Health Specialist (REHS) that has gone through extensive training and licensure. Timely inspections of retail food establishments, septic systems, lakes, camps and public health nuisances are conducted. Local and state regulations, such as **Chapter 24** (N.J.A.C. 8:24) *"Sanitation in Retail Food Establishments and Food and Beverage Vending Machines"* are enforced. Environmental stewardship through education and grant activities help to maintain the pristine beauty of the New Jersey Highlands Region.

ANIMAL CONTROL

Animal Control Services are provided through a shared services agreement with the Borough of Bloomingdale. With the oversight of the Animal Control Officer (ACO), Lisa Perry, and her staff, they provide compassionate and competent services for domestic pets and wildlife. Services include support with animal licensing, canvassing and enforcement; rabies control through rabies vaccine clinics, enforcement of state and local laws, and investigation of suspected cases of rabies; responding to calls about strays or animals in distress; and all other requests related to animals. An annual free rabies clinic is held each year in November to vaccinate dogs and cats. Annual licensure of dogs/cats is required each year by January 31st.
