**NOTICE OF WATER FLUSHING**

PLEASE TAKE NOTICE that the Ringwood Water Department will be flushing water mains throughout the Borough Monday through Friday during the weeks of **April 19 – April 23 and April 26 – April 29**. **The hours of flushing will begin at 9:00 A.M. and end at 5:00 P.M.** Some discoloration and lowered pressure may be experienced during this period. **Homeowners are advised to turn the water off at the valve where the water enters the house from the outside service line.** This will prevent air from re-entering the line during the flushing process.

TAKE FURTHER NOTICE that flushing will take place at various locations according to the following schedule and could affect other roads without hydrants. Questions may be directed to the Department of Public Works at (973-475-7103).
