Directions to Ringwood Borough Hall

From the South

Take Route 287 North to Exit 57 (Skyline Drive). At the end of the ramp is a traffic light – make left and go straight through next traffic light (under Route 287). Go over Skyline Drive (approximately 4 miles). At stop sign go straight (St. Catherine's Church will be on your right). Bear right at the fork in the road which puts you on Route 511 - Greenwood Lake Turnpike (approximately 2 miles). At the second right (Sloatsburg Road) – make right. Continue approximately 2 miles and make the first left onto Margaret King Avenue. Borough Hall is on your right hand side - approximately 300 yards.

From the North

Take 87 South to 287 South and get off at Exit 57 (Skyline Drive). Bear right and go over Skyline Drive (approximately 4 miles). At stop sign go straight (St. Catherine's Church will be on your right). Bear right at the fork in the road which puts you on Route 511 - Greenwood Lake Turnpike (approximately 2 miles). At the second right (Sloatsburg Road) – make right. Continue approximately 2 miles and make the first left onto Margaret King Avenue. Borough Hall is on your right hand side - approximately 300 yards.

Directions from NYC

Exit New York City via George Washington Bridge and get on Route 4 West. Take Route 208 North to 287 South and get off at Exit 57 (Skyline Drive). Bear right and go over Skyline Drive (approximately 4 miles). At stop sign go straight (St. Catherine's Church will be on your right). Bear right at the fork in the road which puts you on Route 511 - Greenwood Lake Turnpike (approximately 2 miles). At the second right (Sloatsburg Road) – make right. Continue approximately 2 miles and make the first left onto Margaret King Avenue. Borough Hall is on your right hand side - approximately 300 yards.

LANDLORD REGISTRATION/TENANTS

A landlord who owns a one- or two-family non-owner occupied house is required by law to file the necessary registration statement with the Municipal Clerk of that municipality. If the building had three or more units, the statement must be filed with the Bureau of Housing Inspection, CN810, Trenton, NJ 08625-0810. No filing is required for the owner-occupied two-family houses. EMERGENCY SCHOOL CLOSINGS OR DELAYED OPENING OF SCHOOLS FOR INCLEMENT WEATHER

In the event of inclement weather, mechanical breakdown, or other unexpected occurrences, the Ringwood Public Schools may need to be closed during part or all of a regularly scheduled school day. The Superintendent of Schools, after consultation with district personnel and, when necessary, borough officials, is responsible for making the decision to close the schools. This decision is never taken lightly, and is only undertaken when the safety or well being of our students is at risk. It is critical that your child's school has an up-to-date emergency contact number for you or another responsible adult. ***If you are unable to be home, it is extremely important that you designate someone who will be willing to care for your child in the event of an emergency closing, and discuss this plan with your child and the caregiver in advance.*** When the Ringwood Public Schools will be closed, on an emergency basis, for all or part of the day, parents/guardians are notified as follows:

Website: All emergency closings will be posted on the homepage of the district website.

Emergency Closing Hotline: To receive information about emergency closings, parents/guardians may call 973-962-0331 for a recorded message.

Radio: Emergency closings will be announced on WGHT-1500AM.

Television: Emergency closings will be broadcast on Channel 77 (Cablevision).

Alert Now: If you wish to receive a call through our emergency notification system, or to make changes to the phone numbers you provided, please contact the secretary at your child's school.

Jerry Wyckoff Natural Preserve

The Jerry Wyckoff Natural Preserve property is a high visible 7-acre parcel along Skyline Drive which was purchased and protected by the Borough to maintain the rugged, rural character of Ringwood, and to ensure the site's use is compatible with the long-term protection of water quality for the Wanaque Reservoir. It is the first open space initiative led exclusively by the Borough. Once slated for a one hundred unit Assisted Living Complex, this wooded and steeply sloped commercially-zoned parcel would have been the site of the largest building in Ringwood. Located at the entrance to the center of town from Route 287, the property is a natural plateau accessible from Fieldstone Drive, capable of serving as both a scenic overlook and public gathering place for outdoor ceremonies and community events. The Preserve is named for the first chair of the Ringwood Environmental Commission.

BOROUGH OF RINGWOOD PLANNING BOARD

The Ringwood Planning Board was established to perform the duties of a municipal Planning Board as outlined in the Municipal Land Use Law. The Board consists of nine members and two alternates. Members include the Mayor, a member of the Borough Council as well as nine residents of the community. The resident members are appointed by the Mayor.

The Ringwood Planning Board's statutory responsibilities are as follows:

- Prepare, adopt and periodically reexamine a Master Plan for the development of the Borough.
- Review Subdivision and Site Plan Applications.
- Maintain files on municipal Master Plans and development regulations.
