Notice is hereby given that sealed bids will be received by the Borough of Ringwood, for **CURBSIDE COLLECTION, REMOVAL, TRANSPORTATION & DISPOSAL OF SOLID WASTE AND RECYCLABLE MATERIALS, Contract No. 2024-101** and will be opened and read in public at Ringwood Borough Hall, 60 Margaret King Avenue, Ringwood, New Jersey 07456, on **Wednesday, April 24, 2024 at 1:00 P.M.** prevailing time.

Plans, specifications and forms of bid for this contract have been filed in the office of said BOROUGH CLERK at 60 Margaret King Avenue, Ringwood, New Jersey 07456 and may be inspected by prospective bidders during regular business hours. Bidders will be furnished with a copy of the Specifications, Plans and Proposal by the BOROUGH CLERK at the cost of preparation thereof, \$30.00, non-refundable; plus \$15.00 postage and handling, if mailed.

Bids must be made on the standard Proposal form in the manner designated therein and must be enclosed in a sealed envelope bearing the name and address of the bidder and the name of the project on the outside, addressed to the Borough of Ringwood at 60 Margaret King Avenue, Ringwood, New Jersey 07456, and must be accompanied by a Certified Check, Bid Bond or Cashier's Check drawn to the order of the Borough of Ringwood for ten (10%) percent of the total amount bid, provided said security need not be more than Twenty Thousand (\$20,000.00) Dollars. All bid guarantees shall be accompanied by an executed consent form from an approved surety company, licensed to conduct business in the State of New Jersey, agreeing to furnish the required Performance and Maintenance Bond upon the award of contract.

The signed Proposal forms and bid security must be delivered to the place on or before the hour named above. The accepted bidder must sign the contract within ten (10) days after the Notice of Award or forfeit his bid security. Bid securities will be returned to all but the three apparent lowest responsible bidders. All other bid securities will be returned within three working days after awarding and signing of the contract and approval of the Contractor's Performance Bond, Saturdays, Sundays and Holidays excepted.

All bidders are required to comply with the requirements (Affirmative Action Regulations of N.J.S.A. 10:5-31 et seq. and to N.J.A.C. 17:27, as amended and supplemented from time to time.

The right is reserved to reject any or all Proposals, in whole or in part, or to make awards to such bidder or bidders who, in the judgment of the Borough of Ringwood, make the most advantageous bid and to waive such informalities as may be permitted by law.
